TOP DELINQUENT TAXPAYERS**

This list of top delinquent taxpayers is based on New Mexico liens filed for established liabilities by the New Mexico Taxation and Revenue Department. This list does not include taxpayers that are currently on an installment agreement, in bankruptcy or in a formal protest.

The New Mexico Taxation and Revenue Department will update this list on a monthly basis. A taxpayer will be removed from the list upon payment of the liability including penalty and interest. Taxpayers may also enter into an acceptable installment agreement to be removed from the list.

The actual amount currently owed may be higher or lower, depending on how much time has passed since the lien was filed or if the original amount due has been reduced by any credits.
