E-FILE BILLBOARDS IN 7 LOCATIONS STATEWIDE

SANTA FE - TRD billboards advertising the benefits of Electronic Filing, are now displayed in 7 locations around the state. These locations are: Roswell, Carlsbad, Las Cruces, Gallup, Farmington, Albuquerque and Santa Fe. Locations in Las Cruces and Albuquerque are also in Spanish. E-Filing for Personal Income Tax Returns was launched for the tax year 2006, on January 16, 2007. This is the nineteenth year some form of e-filing has been available to New Mexico Taxpayers. As of this week, 95% of the returns filed for Personal Income Tax were submitted electronically.

"I want to encourage all New Mexicans to file their tax returns online-not only will you receive your refund check within 7 days-we can also deposit your refund check directly into your personal checking or savings account," stated Jan Goodwin, Secretary of Taxation and Revenue. E-filing is fast, free and secure. TRD has steadily increased the per cent of returns filed electronically-48% for the 2005 tax season and 51% for 2006. E-Filing allows you until April 30, 2007 to file your tax return. This free and easy service is available today by logging on to our website at www.state.nm.us/tax.
