Taxation and Revenue Secretary Jan Goodwin will be assisting taxpayers with personal income tax returns at our **Santa Fe office, Friday, February 23, 2007 from 10 AM to 12 Noon.** The Secretary wants to highlight the free tax return services that TRD provides with TaxHelp New Mexico, to prepare and electronically file low income personal income taxes. Secretary Goodwin is looking forward to helping out. "I look forward to joining the men and women who volunteer their services each year to help their fellow New Mexicans. We are here to serve." For state purposes, low income individuals are those with a combined income of \$22,000 or less for tax year 2006 and for federal/state filing purposes, combined income must be below \$39,000.

New Mexico Taxation & Revenue will prepare and electronically file state income tax returns at their offices in Albuquerque, Santa Fe, Las Cruces and Roswell. Below is a listing of the office addresses and preparation times. Tax Help New Mexico will prepare and electronically file both federal and state income tax returns throughout the state including some Taxation & Revenue offices. New in 2007 are Saturday Personal Income Tax preparation hours for qualified individuals at Taxation & Revenue offices in Albuquerque, Santa Fe, Las Cruces and Roswell. Saturday hours will begin on February 3, 2007
