The list entitled "New Mexico Top Delinquent Taxpayers" is based on New Mexico liens filed by the New Mexico Taxation and Revenue Department for established tax liabilities. The list does not include taxpayers that are currently on an installment agreement or in a formal protest.

The New Mexico Taxation and Revenue Department routinely updates the list. Taxpayers can be removed from the list upon payment of the liability including accrued penalty and interest. Taxpayers can also enter into an approved payment plan to be removed from the list.
