August Tax Workshops for New Businesses

The New Mexico Taxation and Revenue Department will present its New Business Workshop in various locations around the state in August. The workshop is intended for new business owners and others who want an introduction to business tax reporting in New Mexico.

The workshops cover such topics as the Combined Reporting System for Gross Receipts, Withholding and Compensating Tax programs; Non-Taxable Transaction Certificates; estimated income tax payments for business owners, deductions and exemptions from Gross Receipts and e-filing. Full-day workshops also include a volunteer CPA who discusses federal tax issues and good business practices.
